After School Activities

Most of the after school activities for Grades 1-12 are on a first come first-service sign-up basis. Most of the after school activities are included in the tuition, unless the instructor is not an employee at RVIS, whereby the parents will pay the instructor directly for that particular activity.

TERMS AND CONDITIONS OF ENROLLMENT

1. School personnel will take appropriate action in the case of a medical emergency, under the conditions of the student Treatment & Travel Permission Form.
2. Any conduct by a RVIS student which the school authorities consider detrimental to the student, or to other students, or to the school itself may be deemed adequate cause for appropriate disciplinary action, including suspension or dismissal from RVIS.
