- Formal disciplinary action as outlined in the RVIS Code of Conduct and Ministry of Education

RVIS is committed to helping students meet these expectations. Support may include:

- Guidance and coaching from teachers, advisors, or school counselors
- Opportunities to reflect and reset through restorative approaches
- Clear communication between home and school to support positive outcomes
