3. Respect School Property and Community

- Keep classrooms, hallways, and outdoor areas clean
- Use technology responsibly, following the RVIS Acceptable Use Policy

4. Act Responsibly and Safely

- Follow school rules, routines, and teachers' instructions
- Make choices that keep myself and others safe
- Represent RVIS positively both in and out of school

Consequences

If I do not follow these expectations, I understand that:

- I may be asked to reflect on my behavior with a teacher or advisor
- My parents/guardians may be contacted
- I may lose privileges (e.g., participating in certain activities or events)
- I may need to repair harm through restorative practices
- Repeated or serious behavior issues may lead to further disciplinary action in line with the RVIS Code of Conduct and the Ministry of Education

- Providing guidance from teachers, advisors, or counselors
- Helping me reflect on my choices and how they affect others
- Working with my parents/guardians to help me succeed
